Item #2 Educational Background and Business Experience

Dane DeBartolo was born in 1990. He earned a high school diploma from Middletown High School South. Mr. DeBartolo has no formal education after high school.

Mr. DeBartolo has been the owner and Chief Executive Officer of Jersey Junkers® since 2012. His business background includes overseeing operations, management, and strategic decision-making for the company. Mr. DeBartolo has been actively engaged in this role for more than five years.

Item #3 Disciplinary Information

A. Criminal or Civil Actions

Neither Capital B Advisory Services nor its Firm Principal, Dane DeBartolo:

1. has been convicted of, or pled guilty or nolo contendere ("no contest") to:
 - (a) any felony;
 - (b) a misdemeanor that involved investments or an investment-related business, fraud, false statements or omissions, wrongful taking of property, bribery, perjury, forgery, counterfeiting, or extortion; or
 - (c) a conspiracy to commit any of these offenses;
2. is the named subject of a pending criminal proceeding that involves an investment-related business, fraud, false statements or omissions, wrongful taking of property, bribery, perjury, forgery, counterfeiting, extortion, or a conspiracy to commit any of these offenses;
3. has been found to have been involved in a violation of an investment-related statute or regulation; or
4. has been the subject of any order, judgment, or decree permanently or temporarily enjoining, or otherwise limiting, Capital B Advisory Services or Dane DeBartolo from engaging in any investment-related activity, or from violating any investment-related statute, rule, or order.

B. Administrative Proceedings

Neither Capital B Advisory Services nor its Firm Principal, Dane DeBartolo:

1. has been found to have caused an investment-related business to lose its authorization to do business; or
2. has been found to have been involved in a violation of an investment-related statute or regulation and been the subject of an order by the SEC, any other federal regulatory agency, any state regulatory agency, or any foreign financial regulatory authority:
 - (a) denying, suspending, or revoking the authorization of Dane DeBartolo to act in an investment-related business;
 - (b) barring or suspending Dane DeBartolo's association with an investment-related business;
 - (c) otherwise significantly limiting Dane DeBartolo's investment-related activities; or
 - (d) imposing a civil money penalty of more than \$2,500 on Dane DeBartolo.

C. Self-Regulatory Organization (SRO) Proceedings

D. Other Proceedings

Neither Capital B Advisory Services nor its Firm Principal, Dane DeBartolo, has been the subject of any hearing or formal adjudication in which a professional attainment, designation, or license was revoked or suspended because of a violation of rules relating to professional conduct.

Neither Capital B Advisory Services nor Dane DeBartolo has resigned or otherwise relinquished a professional attainment, designation, or license in anticipation of such a hearing or formal adjudication.

Item #4 Other Business Activities

A.

Dane DeBartolo is not actively engaged in any other investment-related business or occupation. He is not registered, and does not have an application pending to register, as a broker-dealer, registered representative of a broker-dealer, futures commission merchant, commodity pool operator, commodity trading advisor, or associated person of any such entity. He does not receive commissions, bonuses, or other compensation based on the sale of securities or investment products.

1. At this time, neither Capital B Advisory Services nor its Firm Principal, Dane DeBartolo, engages in any outside financial industry activities that create a material conflict of interest with advisory clients.
2. At this time, neither Capital B Advisory Services nor its Firm Principal, Dane DeBartolo, receives commissions, bonuses, trail fees, or any other compensation based on the sale of securities or other investment products.

Neither the Firm nor Dane DeBartolo is registered as a broker-dealer or registered representative of a broker-dealer, and neither receives compensation for the sale of mutual funds, insurance products, or other investment-related products.

Accordingly, Capital B Advisory Services does not have compensation-related incentives to recommend particular securities or investment products based on commissions or other sales-based compensation rather than a client's needs and objectives.
